Budget

Dues add up to \$8100 and our expenses have been \$7000. We need to raise our dues to keep up the increasing operating costs

We also need to have a reserve study done but do not think we have enough money to complete

that at this time.

ARC applications

ARC approved the installation of permanent LED lights on the exterior of home. These

Professionally installed permanent lights that are in a matching track to house color

are lights that are attached to the trim via a channel that is same color of the trim. They are barely visible. This change amends CCR 6.17 that states you can't keep holiday lights up more than a month after the holiday. is allowed. These lights are hidden and barely visible in the daylight. We are not allowing string Christmas lights to stay up all year.
